COMPLIANCE WITH CURRENT INTERNATIONAL PLUMBING CODE. ENERGY CODE COMPLIANCE REQUIRED.

1" POLYETHYLENE PIPE REQUIRED FOR GAS LINES/GROUND. INSIDE HOUSE PIPES MUST BE BLACK PIPE – NOT GALVANIZED OR IRON.

Plumbing fixtures include toilets, urinals, fountains, bathtubs, showers, sinks, lavatories, stop sinks, interceptors, washing machine, and floor drains.

All permit applications must be accompanied by plans of all work expected to be done, showing the course and grades of all drainpipes. The course and location of all soil, vent and water pipes, the arrangement of all connections of all fixtures, the position of traps and the manner of ventilating and such other details as the City Inspector/Engineer may require.

**PLEASE ALLOW 10 BUSINESS DAYS FOR PLAN APPROVAL. NO REFUNDS.  
24 to 48 HOURS NOTICE REQUIRED ON ALL INSPECTIONS.**

**DOUBLE FEES:** All permit, inspection, and plan review fees shall apply; except that if any person shall make an application for a permit as provided in this division, after the work has been started or after the work has been partially completed or concealed, such person shall pay double the fee or fees which would ordinarily be required.

**RE-INSPECTION:** Should the Building Inspector be asked by the permit holder to re-inspect the work, and upon attempting to re-inspect finds that the work is not ready for re-inspection, there shall be a \$35.00 re-inspection fee charged.

I the undersigned, in consideration of the City of Magnolia issuing to me this Plumbing Permit, do herewith understand and agree that I will abide by, observe and comply with all applicable laws, codes and ordinances of the City of Magnolia in the installation and maintenance of said improvements.
