# 10. ANNEXATION/ETJ UPDATE

Update of annexation/ETJ proceedings.

Executive Director/City Administrator Paul Mendes reported that we are working on annexation right now with notification to TxDot, MISD, BNSF Railroad and the County to pick up the TxDot flyover interchange areas, the MISD property and Mill Creek Road; the piece of property at Old Hockley/1488 is being cleared and graded again and we have an agreement with the engineers to run water into our stream in the park; they have requested water from us and it has been approved and have given us the plans to connect to is and as soon as they connect to our water, we can annex them. Chief Enloe wants us to include 1488 to the city limits. We would take the area between us and the high school, all the way down from Community Drive all the way in to Magnolia. At a class he attended, Mr. Mendes stated that he found that when you have a development agreement with a piece of property with a development area like Legacy, it can be regarded as part of the city limits even though it is not being taxed and it is not yours for possession, it can be regarded as part of the city. This pushes our city limits all the way out to 149 for all practical purposes and allows us to extend our ETJ in all directions and to allow us to pick up other pieces of property. CanRig has petitioned us for water and sewer, we have agreed to it, the connections have been made while running the pipeline east, and once the pipes become hot and they start using it, we will annex them in about six months. Mr. Mendes further updated the Board on the latest plans and issues for 249 and Magnolia Ridge. Mr. Mendes lastly stated that he would like to schedule a workshop with Council, 4A, 4B, P&ZC to explore the benefits of applying a TIRZ over the entire city.
