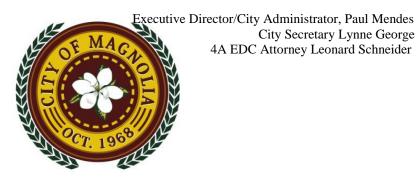

3. CONSIDERATION **TEXAS OFFER FROM DEPARTMENT**

TRANSPORTATION FOR A 0.063 ACRE TRACT Consideration and possible action concerning an offer from the Texas Department of Transportation for a 0.063 acre tract owned by the City of Magnolia 4A Economic

Development Corp., located at the north corner of FM 1488 and Smith Road in Magnolia Texas.

President Williams stated that TxDot has offered \$26,095.00 for a 0.063 acre tract of land owned by 4A EDC. Discussion followed. Pat Zaiontz stated he understood that if we let them take possession and go ahead so they could move forward before the final deal was done, they would pay an additional \$3,000.00 immediately up front. Basil Tate confirmed that was his understanding as well and commented that the \$26,095.00 was negotiable.

MOTION: Upon a motion to authorize 4A EDC President Jonny Williams to negotiate on behalf of 4A EDC made by Basil Tate and seconded by Anne Sundquist, the Board members voted and the motion carried unanimously.

4. <u>CONSIDERATION – 4A EDC'S 44-ACRE TRACT OF LAND LOCATED AT FM</u> 149 AND THE DONATION OF LAND FOR A ROADWAY

Consideration and possible action concerning the 4A EDC's 44 acre tract located at FM 149 and the donation of land for a roadway.

Economic Development Coordinator/Planning Tech Tana Ross stated that Sam Yager with the Audubon development desires to build a road for mobility/connectivity/traffic relief through the middle of the land owned by 4A EDC out to FM 149 by taking Mill Creek on the north side of FM 1488, turn it a bit on the end and align it to come across on the other side of CanRig and down and turn east through the 4A property. They would build the road and our contribution would be to donate the land/ROW for the road. Discussion followed.

MOTION: Upon a motion to authorize President Jonny Williams and Executive Director/City Administrator Paul Mendes to come up with a plan and bring it to the next meeting for consideration made by Pat Zaiontz and seconded by Robert Franklin, the Board members voted and the motion carried unanimously.
