## NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of .4529 per \$100 valuation has been proposed by the governing body of City of Magnolia.

PROPOSED TAX RATE \$0.4529 per \$100
NO-NEW REVENUE TAX RATE \$0.4529 per \$100
VOTER-APPROVAL TAX RATE \$0.4635 per \$100
DE MINIMIS RATE \$0.6684 per \$100

The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for City of Magnolia from the same properties in both the 2019 tax year and the 2020 tax year.

The voter-approval tax rate is the highest tax rate that City of Magnolia may adopt without holding an election to seek voter approval of the rate, unless the de minimis rate for City of Magnolia exceeds the voter-approval tax rate for City of Magnolia.

The de minimis rate is the rate equal to the sum of the no-new-revenue maintenance and operations rate for City of Magnolia, the rate that will raise \$500,000, and the current debt rate for City of Magnolia.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that City of Magnolia is not proposing to increase property taxes for the 2020 tax year.

A public meeting to vote on the proposed tax rate will be held on August 25, 2020 at 7:00 PM at 18111 Buddy Riley Blvd, Magnolia Texas 77354.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, City of Magnolia is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the City Council of City of Magnolia at their offices or by attending the public meeting mentioned above.

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.
