ORDINANCE NO. O-2022-016

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MAGNOLIA, PROVIDING FOR CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION ON MAY 7, 2022, FOR THE PURPOSE OF ELECTING A MAYOR AND TWO (2) COUNCIL MEMBERS, AND THE SPECIAL ELECTION FOR THE PURPOSE OF SUBMITTING TO THE QUALIFIED VOTERS OF THE CITY ONE PROPOSITION TO REAUTHORIZE THE LOCAL SALES AND USE TAX IN THE CITY OF MAGNOLIA, TEXAS AT THE RATE OF ONE-FOURTH OF ONE PERCENT FOR MAINTENANCE AND REPAIR OF MUNICIPAL STREETS .

* * * * *

WHEREAS, the City of Magnolia, Texas (the “City”) pursuant to the laws of the State of Texas, as amended, is required to hold a general election by State Law which requires the general election for 2022 to be held on the first Saturday of May to elect a Mayor and two Councilpersons, whose terms are expiring, and for the purpose of a special election submitting to the qualified voters of the City one (1) proposition to reauthorize the local sales and use tax in the City of Magnolia, Texas at the rate of one-fourth of one percent for maintenance and repair of municipal streets; and

WHEREAS, pursuant to Chapters 31 and 271 of the Texas Election Code, the City is authorized to enter into a Joint Election Agreement with the Magnolia Independent School District and Contract for Election Services and Election Agreement with Montgomery County and the City has entered into said agreements; and

WHEREAS, by state law and uniform election date for the month of May 2022 falls on May 7, 2022; and

WHEREAS, a general election was held in the City of Magnolia, Texas, on May 7, 2022, at which election it was submitted to the resident qualified voters of the City for the purpose of electing the following officials of the City:

- Mayor, for a two-year term ending May 2024; and
- Council Position 4, for a two-year term ending May 2024; and
- Council Position 5, for a two-year term ending May 2024; and

WHEREAS, a special election was held in the City of Magnolia, Texas, on May 7, 2022, at which election it was submitted to the resident qualified voters of the City one (1) proposition to reauthorize the local sales and use tax in the City of Magnolia, Texas at the rate of one-fourth of one percent:

- Proposition to reauthorize the local sales and use tax in the City of Magnolia, Texas at the rate of one-fourth of one percent to continue providing revenue for maintenance and repair of municipal streets.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MAGNOLIA, TEXAS:

Section 1. Findings. The facts and opinions in the preamble to this Ordinance are true and correct.

election for the office of Mayor, and accordingly, Todd Kana is declared elected to the office of Mayor, subject to the taking of his oath. Brenda Hoppe received a majority of the votes cast at the election for the office of Councilmember, Position No. 4, and accordingly, Brenda Hoppe is declared elected to the office of Councilmember, Position No. 4, subject to the taking of her oath. Jack L Huitt Jr. received a majority of the votes cast at the election for the office of Councilmember, Position No. 5, and accordingly, Josh Abernathy is declared elected to the office of Councilmember, Position No. 5, subject to the taking of his oath. The local sales and use tax in the City of Magnolia Texas was reauthorized at the rate of one-fourth of one percent to continue providing revenue for maintenance and repair of municipal streets and will expire on the fourth anniversary of this election unless the imposition of the tax is reauthorized.

Section 4. The election held in and throughout the City of Magnolia, Texas, on the 7th day of May 2022, which election is more particularly described in the preamble of this Ordinance, was duly called and notice thereof was given and the election was held under and in strict conformity with law; that only duly qualified resident electors of the City voted at the election; that due returns of the election have been made by the proper officers.

Section 5. It is hereby officially found and determined that notice of the meeting at which this Ordinance is adopted was given as required by the Texas Open Meeting Act, and that such meeting has been open to the public at all times when this Ordinance was discussed and acted upon.

ORDINANCE NO. O-2022-017

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MAGNOLIA, TEXAS RESCINDING ORDINANCE NO. O-2022-007 MAKING FINDINGS OF FACT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Magnolia previously adopted Ordinance O-2022-007 approving the rezoning a tract of land of approximately 0.9183 acres at 31525 Nichols Sawmill Road, Magnolia, Texas (the "Property") from Neighborhood Conservation 2 (NC.2) to Suburban Village (SV).

WHEREAS, after review and study of the procedures followed for the rezoning the City Council determines that it is appropriate to restart the process to consider the application to rezone the Property.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MAGNOLIA, TEXAS, THAT:

Section 1. Findings. The City Council finds that the facts and matters set forth in the preamble of this Ordinance are true and correct.

Section 2. That Ordinance No. O-2022-007 previously adopted and passed by the City Council is hereby rescinded in its entirety.

Section 3. Severability. It is hereby declared to be the intention of the City Council that the phrases, clauses, sentences, paragraphs and sections of this ordinance be severable, and if any phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences or sections of this ordinance, and the remainder of this Ordinance shall be enforced as written.

Section 4. Compliance Clause and Effective Date. The City Council finds, determines and declares that a sufficient written notice was posted and this Ordinance was passed in accordance with the Open Meetings Act and that this Ordinance takes effect immediately upon passage and approval by the City Council.

Section 5. The Official Zoning Map of the City of Magnolia shall be reviewed and amended if necessary to show the Property was not rezoned by Ordinance O-2022-007.

Section 6. The City Secretary is instructed to attach this Ordinance to Ordinance No. O-2022-007.





