**WHEREAS**, a special election was held in the City of Magnolia, Texas, on May 7, 2022, at which election it was submitted to the resident qualified voters of the City one (1) proposition to reauthorize the local sales and use tax in the City of Magnolia, Texas at the rate of one-fourth of one percent:

 Proposition to reauthorize the local sales and use tax in the City of Magnolia, Texas at the rate of one-fourth of one percent to continue providing revenue for maintenance and repair of municipal streets.

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MAGNOLIA, TEXAS:

#### **ORDINANCE NO. 0-2022-017**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MAGNOLIA, TEXAS RESCINDING ORDINANCE NO. O-2022-007 MAKING FINDINGS OF FACT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

- <u>Section 4.</u> Compliance Clause and Effective Date. The City Council finds, determines and declares that a sufficient written notice was posted and this Ordinance was passed in accordance with the Open Meetings Act and that this Ordinance takes effect immediately upon passage and approval by the City Council.
- <u>Section 5.</u> The Official Zoning Map of the City of Magnolia shall be reviewed and amended if necessary to show the Property was not rezoned by Ordinance O-2022-007.
- **Section 6.** The City Secretary is instructed to attach this Ordinance to Ordinance No. O-2022-007.


