# MINUTES OF PUBLIC MEETING OF THE MAGNOLIA CITY COUNCIL NOVEMBER 14, 2023

A meeting of the City Council was held on this date, November 14, 2023, beginning at 6:00 pm in the Sewall Smith Council Chambers 18111 Buddy Riley Blvd., Magnolia, Texas 77354.

### 1. CALL MEETING TO ORDER

Mayor Todd Kana called the meeting to order at 6:00 pm.

- a. INVOCATION
  - Councilmember Dantzer delivered the invocation.
- b. PLEDGE OF ALLEGIANCE

Mayor Kana led the Pledge of Allegiance to the USA and Texas flags.

c. ROLL CALL AND CERTIFICATION OF A QUORUM

Mayor Kana called the roll and certified a quorum was present with the following Council members in attendance: Todd Kana, Richard Carby, Daniel Miller, Matthew Dantzer, Brenda Hoppe, and Jack L Huitt Jr.
