MINUTES OF THE PUBLIC HEARING AND REGULAR MEETING OF THE CITY COUNCIL OF THE CITY OF MAGNOLIA DECEMBER 14, 2021

A meeting of the City Council was held on this date, December 14, 2021, beginning at 7:00 p.m. in the Sewall Smith Council Chambers, 18111 Buddy Riley Boulevard, Magnolia, Texas 77354.

1. CALL MEETING TO ORDER

Mayor Todd Kana convened the meeting at 7:00 p.m.

- a. INVOCATION
 Leonard Schneider delivered the invocation.
- PLEDGE OF ALLEGIANCE
 Mayor Kana led the Pledge of Allegiance to the U.S.A. and Texas flags.
- c. ROLL CALL AND CERTIFICATION OF QUORUM Mayor Kana called roll, certified that a quorum was present with the following Council members in attendance: Todd Kana, Daniel Miller, Matthew Dantzer, and Brenda Hoppe.

Absent: Rick Carby and Josh Abernathy

Staff present: City Administrator Don Doering, City Secretary Kandice Garrett, and Police Chief Kyle Montgomery

2. **PUBLIC COMMENTS** (Generally limited to three minutes per person; in accordance with state law, the time may be reduced if there is a high number of speakers or other considerations.)

Jane Khalimova, 40374 Blossom Valley Ln., Magnolia, TX 77354 spoke to Council regarding her water bill and felt that it was a high amount for her household. Staff and the Mayor explained that the water bill seems to be in line with the average user according to the City's rates; however, some other customers living in Mill Creek are having issues with excessively high water bills and the City is addressing that problem.

Rachel Steele presented the 4B Capital Improvements Draft Project List to Council.

9. CONSIDERATION, DISCUSSION, AND POSSIBLE ACTION TO APPROVE AMENDMENT NO. 3 FOR STRAND ASSOCIATES, INC. ON THE NICHOLS SAWMILL SANITARY SEWER PHASE III PROJECT (Mayor Todd Kana)

Consideration, discussion, and possible action to approve Amendment No. 3 to the August

20, 2018, Owner-Engineer Agreement for the Nichols Sawmill Sanitary Sewer Phase III Project.

Kelly Hajek with Strand explained to Council this Amendment addresses the issue of the contractor backing out of the project and the need to rebid for their replacement as well as provide a clean break from the project as it is being handed off to AEI Engineering. The proposed Amendment is a net deduction for \$56,196.

MOTION: Upon a motion to approve Amendment No. 3 for Strand Associates, Inc. on the Nichols Sawmill Sanitary Sewer Phase III Project made by Councilmember Hoppe and seconded by Councilmember Dantzer, the Councilmembers voted, and the motion carried unanimously, 3-0.

SEWER IMPROVEMENTS PROJECT PHASE II, CDBG-DR CONTRACT NO. 19-076-015-B364 - 2016 FLOOD (Mayor Todd Kana)

Kelly Hajek with Strand reviewed the bid process for Council and stated that the City received six bids with Ballast Point Construction, out of Katy, TX being the lowest bidder at \$492,575.75 below the opinion of Engineer's probable cost. Although Strand has not worked with Ballast they were able to get two references with the same engineering firm. After further discussion it was decided to award the bid to Ballast.

City Attorney Leonard Schneider informed Council of the process to amend impact fees which the City last did in 2019 and that is appointing an Advisory Committee, likely to be the Planning and Zoning Commission to review the study provided by the Engineer, make

recommendations to City Council, file a Land Use Assumptions and Capital Improvement Plan, have public hearings (may take up 120 days).

MOTION: Upon a motion to direct staff to start process to : (i) update Land Use Assumptions and Capital Improvement Plans; (ii) to amend impact fee made by Councilmember Hoppe and seconded by Councilmember Miller, the Councilmembers voted, and the motion carried unanimously, 3-0.

City Administrator Don Doering informed the Council that the City is paying \$47,100 annually to a local contractor including Unity Park and various roadsides. The City could purchase all the needed equipment for \$32,000 and use City staff to get the job done. He noted that 4B has already cancelled the contract and he is seeking approval from Council to cancel the contract, purchase equipment and mow in-house.

MOTION: Upon a motion to cancel contract with mowing contractor and purchase mowing equipment to be used by City staff made by Councilmember Hoppe and seconded by Councilmember Dantzer, the Councilmembers voted, and the motion carried unanimously, 3-0.

a. POLICE DEPARTMENT (Chief of Police, Kyle Montgomery)

Police Chief Kyle Montgomery reported that it was an uneventful month as stats have gone back down from a high previous month to where they should be. A couple of officers were in training and they hired an officer to replace a vacancy and looking to hire one more in hopes to be complete staff by next month. The K-9 graduated from his academy and may be brought to the next Council meeting for a proper introduction.

- b. PUBLIC WORKS DEPARTMENT (Public Works Director, Don Doering)
- c. ADMINISTRATION DEPARTMENT (City Administrator, Don Doering)

City Administrator Don Doering reported he met with the new waste collection company, GFL (formerly WCA), and they are proposing an amendment to the contract to pick up all the heavy trash every Friday without making a reservation through Utility Billing. Mr. Doering attended a HEB construction update meeting where they inquired about their certificate of occupancy. Mr. Doering also briefly went over a summary of the financials noting that we are significantly over budget in revenue for license and permits, sales tax, water tap fees, sewer tap fees, water impact fees, and sewer impact fees; also noting since March 2020 the City's total taxable value of all the real property in the City has increased 33% at \$75,000,000. The total number of building permits issued in 2019 was 406; total permits issued in 2020 was 799; and total permits issued so far in 2021 is 1,030.
