Ordinance No. 2008-138

ORDINANCE TO PROHIBIT DRILLING, EXPLORATION OR MINING FOR OIL, GAS OR OTHER MINERALS ON THAT CERTAIN TRACT OF LAND BEING a 29.979 acre tract or parcel of land lying and being situated in the Cyrus Wickson Survey, Abstract 601 and the Gamble Dawson Survey, Abstract 177, Montgomery County, Texas, being a portion of a tract said to contain 70.01 acres conveyed to Magnolia Independent School District (M.I.S.D.) by deed recorded in CF#263-00-1050, et seq. of the Official Public Records of Real Property of Montgomery County (O.P.R.R.P.M.C.), said 29.979 acres tract being more particularly described by metes and bounds in "EXHIBIT A" ATTACHED HERETO.

WHEREAS, the City Council of the City of Magnolia, Texas, has applied for a grant for improvements to a tract of land being described as a 29.979 acre tract or parcel of land lying and being situated in the Cyrus Wickson Survey, Abstract 601 and the Gamble Dawson Survey, Abstract 177, Montgomery County, Texas, being a portion of a tract said to contain 70.01 acres conveyed to Magnolia Independent School District (M.I.S.D.) by deed recorded in CF#263-00-1050, et seq. of the Official Public Records of Real Property of Montgomery County (O.P.R.R.P.M.C.), said 29.979 acres tract being more particularly described by metes and bounds in the "Exhibit "A"" attached hereto and incorporated herein (hereinafter the "Property"); and

WHEREAS the said Property is being used for Public Park purposes; and

WHEREAS, to comply with grant requirements, the City of Magnolia, Texas, has no intention of exploring for oil, gas or other minerals or permitting drilling or mining for oil, gas or other minerals on or any pooling of said property; and

WHEREAS drilling on the said property will negatively affect the health, safety and welfare of the city and its inhabitants and would not promote orderly growth and development to the city.

NOW, BE IT ORDAINED by the City Council of the City of Magnolia, Texas,

 That the facts and recitations contained in the preamble of this Ordinance are hereby found and declared to be true and correct.

2. That in the event the City purchases said property, the property shall not be the subject of any mining, drilling for oil, gas or other minerals or exploration of any kind and further the City of Magnolia, Texas, shall not consent to or execute any documents to transfer, sell, assign, or convey or lease any mineral development rights on said property to any person or entity whatsoever.

To the Extent this Ordinance conflicts with Ordinance No. 340 passed and adopted on May 25,
 2004, this Ordinance controls.
