ORDINANCE NO. 0-2019-008

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MAGNOLIA, PROVIDING FOR CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION ON MAY 4, 2019, FOR THE PURPOSE OF ELECTING THREE (3) COUNCIL MEMBERS.

WHEREAS, the City of Magnolia, Texas (the "City") pursuant to the laws of the State of Texas, as amended, is required to hold a general election by State Law which requires the general election for 2019 to be held on the first Saturday of May to elect three Councilpersons, whose terms are expiring; and

WHEREAS, pursuant to Chapters 31 and 271 of the Texas Election Code, the City is authorized to enter into a Joint Election Agreement with the Magnolia Independent School District and Contract for Election Services and Election Agreement with Montgomery County and the City has entered into said agreements; and

WHEREAS, by state law and uniform election date for the month of May 2019 falls on May 4, 2019; and

WHEREAS, a general election was held in the City of Magnolia, Texas, on May 4, 2019, at which election it was submitted to the resident qualified voters of the City for the purpose of electing the following officials of the City:

- Council Position 1, for a two-year term ending May 2021; and
- Council Position 2, for a two-year term ending May 2021; and
- Council Position 3, for a two-year term ending May 2021.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MAGNOLIA, TEXAS:

Section 1. Findings. The facts and opinions in the preamble to this Ordinance are true and correct.
