

ORDINANCE NO. O-2020-021

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MAGNOLIA, TEXAS, AMENDING ORDINANCE NO. O-2020-007 THAT POSTPONED THE GENERAL ELECTION TO BE HELD ON THE 2ND DAY OF MAY, 2020, FOR THE PURPOSE OF ELECTING A MAYOR AND TWO (2) CITY COUNCIL MEMBERS AT LARGE TO THE NOVEMBER 3, 2020 UNIFORM ELECTION DATE; DESIGNATING POLLING PLACES; MAKING OTHER PROVISIONS; PROVIDING A REPEALING CLAUSE; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in accordance with the general laws and Constitution of the State of Texas and the City of Magnolia, Texas, and pursuant to Ordinance No. O-2020-004, a general election was ordered to be held on May 2, 2020, for the purpose of electing a Mayor and two (2) Council Members at large; and;

WHEREAS, pursuant to Section 418.016 of the Texas Government Code, on March 18, 2020, the Governor of the State of Texas signed a proclamation suspending certain provisions of the Texas Election Code and the Texas Water Code to allow all local political subdivisions that are utilizing the May 2, 2020 uniform election date to postpone their elections to the November 3, 2020, uniform election date; and

WHEREAS, pursuant to the Governor's proclamation authorizing the City of Magnolia to postpone the May 2, 2020 election date, the City Council by Ordinance 2020-007 exercised its authority to postpone the General Election ordered for May 2, 2020, for the purpose of electing a Mayor and two (2) Council Members at large to November 3, 2020; and

WHEREAS, Ordinance 2020-007 ordered the postponement of the May 2, 2020 election date and ordered the election to be held November 3, 2020; and

WHEREAS, this ordinance amends Ordinances 2020-007 by providing early voting dates and locations, as provided in the attached amended Exhibit "A"

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MAGNOLIA, TEXAS:

Section 1: That the general election previously ordered for May 2, 2020, for the City of Magnolia, Texas, for the purpose of electing a mayor and two (2) Council Members at large has been postponed and ordered to be held on November 3, 2020 and Ordinance 2020-007 is

amended by providing the early voting dates and voting locations and time and locations on November 3, 2020 in the attached amended Exhibit A.


Section 3. That should any word, sentence, paragraph, subdivision, clause, phrase or section of this ordinance be adjudged or held to be void or unconstitutional, the same shall not affect the validity of the remaining portions of said ordinance, which shall remain in full force and effect.

Section 4. This Ordinance shall take effect immediately from and after its passage as the law and charter in such cases provide.




