Guardian, individually and on behalf of Participant, VOLUNTARILY ELECTS TO ACCEPT ALL RISKS connected with Participant's participation in any activities or events sponsored, organized, sanctioned, and/or held at facilities provided by the City. **Guardian, individually and on behalf of Participant, RELEASES, DISCHARGES AND COVENANTS NOT TO SUE the City, its officers, directors, agents, and employees (all hereinafter collectively referred to as the "Released Parties") from any and all claims and liability arising out of strict liability or ordinary negligence of the Released Parties or any other participant which causes Participant or Guardian personal injury, death, or property damage.** GUARDIAN INDIVIDUALLY AND ON BEHALF OF PARTICIPANT CONVENANTS TO HOLD THE RELEASED PARTIES HARMLESS AND TO INDEMNIFY RELEASED PARTIES FROM ALL CLAIMS, JUDGMENTS, AND/OR THE ACTIVITIES AND EVENTS THAT ARE SPONSORED, ORGANIZED, SANCTIONED, AND/OR HELD AT FACILITIES PROVIDED BY THE City. GUARDIAN'S INDEMNITY OBLIGATION EXTENDS TO ACTS AND OMISSIONS CAUSED BY THE SOLE AND CONCURRENT NEGLIGENCE OF THE City.

Guardian acknowledges that if Participant does not adhere to the activity rules during the activity, Guardian will be notified and requested to pick up the Participant. Guardian hereby gives the representatives of City permission to seek first aid treatment and to consent to emergency medical services on behalf of the Participant should a medical emergency arise. Guardian acknowledges that the City's consent to emergency medical treatment will in no way create an obligation on the part of City to pay for the medical services rendered.
